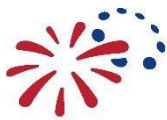

This application is for public vending during the July 4th Celebration on Wednesday, July 4, 2019 ONLY.



Applications will be accepted on a first-come, first-served basis. Duplication of items sold by different vendors will be approved or disapproved based on the items sold and/or other criteria as determined by the Committee. **Any vendor without necessary permit (displayed always), will forfeit all vending privileges and be subject to penalty.**

Stationary vendors will be located at or near the event site along North Shoreline Blvd. Entry & set-up location will be **determined by the Committee** on an individual basis.

All food vendors must apply for and obtain a Health Department Permit by calling 361.826.7273.

**Application Fees: Food Vendors-\$250.00; Merchandise Vendors-\$175.00; Walking Merchandise Vendors-2 for \$175.00**

**Vendor fees are nonrefundable; no exceptions allowed.**

**Pay by June 1<sup>st</sup> for an Early Bird Discount: Food Vendor \$225.00; Others \$160.00**
